Spring Elections

We will be holding AAUW of Maine Council elections in May 2024 and announcing the election results at our annual convention (May 31-June 1). The Council has five elected positions. Terms are for two years, with three positions being filled in even years and two positions being filled in odd years. This year, we will be electing a Council Administrator, Membership Chair, and Communications Chair.

The first step is to form a Nominating Committee, which shall be comprised of one member from each branch. Nominating Committee members serve for one year and meetings will be held via Zoom. As a group, this committee is well placed to identify members from among all the branches who would be a good fit for these positions. If you would like to serve on this year's Nominating Committee, please let your branch leader know.

A call for nominations will officially begin on March 31, and the slate of officers will be sent to all members by April 30.


News from the Program and Public Policy Committee

The Program and Public Policy (PPP) Committee members have been busy making plans for the State Convention. Members include: Mary Cathcart from Penobscot Valley, Judy Fuller from Hancock County, Jackie Kulik from Waterville, and Debbie Melvin from Aroostook. The State Council has approved the theme of Women's Rights for the Conference. The aim is to celebrate the 100th anniversary of the Equal Rights Amendment (ERA), support its re-submission to the U.S. Congress, and to consider how the 2024 election may impact the rights of women.

Convention dates chosen are May 31-June 1 and the location is the Hilton Garden Inn in Bangor. Committee members are in the process of choosing speakers who will support the theme and inspire members to action.

We are resurrecting some of the past traditions of the organization. One is to have a statewide book and include a discussion of the book at some point during the convention. Our selection is *Your Voice, Your Vote* (2020-21 edition): *The Savvy Woman's Guide to Politics, Power, and the Change We Need* by Martha Burk (https://www.marthaburk.org).



It covers a variety of topics related to women's rights. Members can read cover to cover, chose selected chapters of interest, or spread the reading among branch members. The book is available on Amazon for \$17.99 for paperback and \$12.99 kindle. The committee also proposed bringing back the Unsung Hero Award. We will be sending out criteria after our February meeting. Branches should begin to think about a present or former member who has gone above and beyond to support the goals of AAUW and taken action to help raise the status of girls and/or women. We hope to have at least one nomination from each branch.

On the public policy front, there are several things members can do to support the public policy priorities of AAUW. **One is to become a Two-Minute Activist.** You will receive email alerts when an important AAUW priority issue comes up and can quickly take action. Support is also needed for the Equal Rights Amendment to become a valid part of constitutions at both the federal and state level. U. S. Congresswoman Ayanna Pressley (MA-07) introduced Res #25 on January 21st 2023 with 133 co-sponsors. In the Maine 23-24 legislative session, Lois Reckitt introduced LD 1412. Finance Report

In May 2023 the Maine AAUW finances included four Certificates of Deposit which were opened in 2009. The current value of the CDs totaled \$10,793 with each earning anywhere from 0.35% to as little as 0.15% interest rate. Total interest gained in the first five months of 2023 for all four was a "grand" total of \$8.29.

Subsequently, at the end of May \$10,000 was deposited into a new one-year CD at a rate of 4.745%. As of December 31, the total yield to date on that certificate was \$281.54.

The original face value of the four CDs is unknown, but we might assume they started at \$2,000 each. Considering the elapsed time of 14 years since origin, our investment did not yield much of a return over that period. Assuming rates continue to stay high, the rate of return on the new CD should more than exceed the gains of the old deposits by mid 2025.

Timeline from the Maine Department of Labor for Paid Family Medical Leave (PFML), signed into law in Maine on July 11, 2023. Beginning in 2026, eligible workers in the private and public sector will have 12 weeks of paid time off available to them for family or medical reasons including illness, to care for a relative, or for the birth of a child.

- PFML Program Established: October 25, 2023
- Authority Appointed: January 1, 2024
- Rulemaking begins: Spring 2024
- Payroll contributions begin: January 1, 2025
- Benefits begin: May 1, 2026

This hybrid presentation (attend in person or by Zoom) is entitled *From Surviving to Thriving: Ensuring that We Support the Whole International Student.* The speaker is Dr. Rajika Bhandari, an international higher education expert and author of the award-winning memoir *America Calling: A Foreign Student in a Country of Possibility.* She'll share her personal and professional insights on attracting international students, aligning their needs with campus diversity and inclusion efforts, and positioning them for success.

We proudly note that Dr. Bhandari shares frequently that an AAUW international fellowship was instrumental in her completing her graduate studies in the U.S. Once again, all AAUW of Maine members are invited to join us; those who miss it can access the recording through the Fogler Library website.

Pizza and Politics met by Zoom in September, October, and November; we're resuming in January with plenty to discuss. HAPPY ANNIVERSARY! 2024 marks the 100th anniversary of the founding of the Waterville Branch. On February 9, 1914, the branch was founded due to the forward thinking and efforts of Nunetta May Runnals, Dean of Women and Professor of Mathematics at Colby College. In addition, Sam Eddy (Colby '13) has done research in Colby Special Collections and shared her <u>work</u> with Cathy Bevier.

We started our year-long celebration by looking back on the last 100 years and conducting history harvest in January 2024. The Colby archives contains a wealth of information about the branch, in addition to other allied initiatives such as the Waterville Women's Association, and we made a call for members to bring items to enhance this rich collection.

Branch member Beth Clark spent considerable time among the archives and delivered a superb oral review of our interests and activities over the century at our hybrid branch meeting on January 17, 2024 at the Colby Miller Library. Beth, a relatively new member, noted that she recognized the names of many current branch members over recent decades.

The Waterville Branch also held its annual holiday auction in December 2023, and we raised a record-breaking \$1850. This is our main fundraiser of the year and we donate most of the proceeds to national AAUW. Thanks to all who participated!
